INITIAL CHECKOUT: A minimum of 1.0 hour of flight and 1.0 ground instruction covering airspace and the aircraft are required. A separate checkout is required for each type of aircraft flown; night and/or IFR operations.

CURRENCY: 1.0 hour logged flight time with at least three (3) takeoffs and landings to a full stop every sixty (60) days in the most complex **SFS** tricycle gear aircraft. Currency in tail wheel requires a minimum of three (3) takeoffs and landings to a full stop every forty-five (45) days regardless of other aircraft flown.

ALL DAY RENTAL: A minimum of 50% flight time per reservation is required for all aircraft rentals, up to a maximum of 8 hours required flight time in a 24-hour period.

BLOCK TIME: Block time purchases of a minimum \$2000 cash, debit, or check, yield a 5% credit to your account on the deposited amount. Unused block credits are non-refundable and account refunds are charged a \$20 handling fee. **Discount is not available to I-20 or other Non-U.S. Citizen Applicants.** A 3% surcharge will be applied to all credit card transactions.
